to be a real blast!! **Fred Cousins** has been working the hot ditch this winter, and so far has a 3-0 speckled trout on 2 spin for his top entry.

Freshwater action has been spotty to super, depending on the quarry and the location. So far, the Chickahominy River has produced a nice 3-8 chain pickerel for **Bruce Henderson**, but yellow perch action has been below par. Dragon Run produced a 1-0 yellow perch for **Parks Rountrey**. **Travis Ruddock** went to Kerr Lake for a nice 1-6 crappie. The James River gave **Scott Davis** a 2-8 smallmouth. Several blue catfish have also been caught on the James (reported separately).

The hot spot for the month turns out to be the Pamunkey River, where **Glenn Carter** found a hole the size of my Suburban that produced three club record smallmouth bass!! Glenn released club record smallies of 3-7, 4-2 and 4-9 on 6 fly, 6 plug and 2 spin, respectively!!! All from the same hole! And several others were caught to boot! The bad news is that the bass seem to have moved on, since a return trip didn't produce any more. Bass, that is. Glenn and **LeRoy Houser** did find the mother lode of yellow perch while looking for more smallmouth. LeRoy had the top perch, which was a 1-8 on 2 spin. He also set a club record with a 1-7 on 6 spin! Glenn had a pair of 1-6's and a 1-4. One of the 1-6 perch is a new 12 spin record! And to think that all this time I figured Glenn was holed up in his office bustin' the books!!!




Don't Miss the CCA Banquet and Auction

CCA Takes Lead on Changing VMRC

CCA is coordinating a statewide appeal to the new Governor for objective appointments to VMRC. (See the letter on the next page.) If you agree with the letter get folks to sign copies and bring them to the VAC meeting or drop them at Greentop or Flyfish the World. CCA will collect all the letters and deliver them to the Governor in early April (in bushel baskets).

Dear Governor Warner;

As a recreational angler, I am deeply concerned that the Virginia Marine Resources Commission (VMRC) has not been an effective protector of Virginia's finfish and shellfish. As the state agency charged with the protection of our marine resources, two tasks are key to fulfilling this mission. First, the commission must ensure important species are protected from over harvest from both the commercial and recreational sectors. Second, the commission should place a high priority on protecting and enhancing the entire complex of ecosystems that form Virginia's unique estuary and coastal environment. Unfortunately, there has been a long history of inaction and negative steps by the VMRC commissioners that have jeopardized our fisheries. Why has this occurred? Primarily, due to what appears to be the most important priority of the present group of commissioners --- the **short-term protection of commercial fishing jobs** --- at the expense of future fishing jobs, and in conflict with the long-term public interest.

The only way our important marine resources can be protected is to have a commission that is truly reflective of all concerned users/interests in Virginia. Thus, I urgently request your support in structuring the commission to more accurately and fairly reflect this diversity of interest groups. I am not seeking a commission "stacked" by recreational interests. Rather, I seek one that equally reflects commercial and recreational sectors in our economy and society. Additionally, at least one or two individuals should be appointed that have the professional, environmental and scientific perspective to provide unbiased insight on the sound management of our resources.

This letter is not written in response to any one action taken by the commissioners at the VMRC. However, the recent inaction in regard to **striped bass** serves as yet another in the long chain of questionable moves taken by a commercially oriented group of commissioners. In this case, as with so many before, the commissioners ignored the scientifically based recommendations of it's hard-working, over-tasked staff, and failed to implement any provisions to reduce the over harvest of large striped bass in our waters. Unfortunately, this inaction on the part of the commissioners will now very likely result in mandated federal regulations to solve the problem. In another shortsighted move, the commissioners permitted the dredging of **oysters**, some of which were critical brood stock, in the Rappahannock River for two months at a time when the state is spending several million dollars to restore the oyster fishery in that river. In a final example three years ago, against the advise of the VMRC staff, the commission granted an unprecedented number of license exceptions to allow several hundred additional watermen to enter the **blue crab** fishery. Now the commission is faced with having to reduce the harvest as a result of that increase in effort.

In conclusion, I am asking for your assistance to:

- (1) **Review the current make-up of the VMRC** -- does it's composition accurately reflect the various user/interest groups?
- (2) As the terms of various commissioners expire approve the nomination and appointment of new commissioners with more diverse perspectives to include individuals with sound scientific and/or environmental credentials.

Your attention to these important concerns will have the long-lasting effect of protecting and rebuilding our marine resources in such a way that all residents of the Commonwealth will have a coastal environment they may share with the rest of the nation and with generations to come. Thank you for your consideration.

Do you ever wonder why things happen the way they do? I've had reason to contemplate that question the past several days. Yes, that's me in the picture with my hero, Bob Shepherd, and my potential IGFA record blue catfish! And yes, after several days I'm still wondering and still pinching myself, but I just about have the answers figured out. In the final analysis, I had so little to do with the catch that it is scary!

We wouldn't have even been on the James River for a catfish tournament that morning if it weren't for LeRoy Houser. His love for 'catfishin' and extraordinary success over the past several years has been an inspiration for us all. So much so, that what used to be an annual striper tournament at Lake Anna has now become a pair of catfish tournaments on the James. So much so, that a couple dozen club members have joined in the fun who otherwise would probably have fished somewhere else. The proof is in the record book, where LeRoy and Bob have posted two line class records and one pending record.

I wouldn't have even been there if it weren't for Fred Murray and Bob hatching a plan to get me a catfish before my pending surgery. Well, their plan really worked! I met Fred and Jim Farrell at Jordan Point early. Fred's enthusiasm was contagious, and made me even more excited to get the day started. As we waited for Bob, we launched Jim's boat and got Kelly Stafford and his buddy Woody on the water as well. Then Bob arrived for his maiden voyage of LeRoy's old boat, "Sellabration".

I will always remember the morning. It was misty and calm, almost foggy, when we caught up with Fred and Jim. They had been struggling to find bait for the three boats. We joined in the effort and Fred and Bob made countless throws, catching sometimes one, but more often none in the cast net. Fred's profile in the mist standing on the bow was worth a photo, but I didn't think to take one. After about two hours, Fred and Bob had to be worn out, but we finally had enough bait. Now we just had to find the fish.

We split up, with Fred stopping at one of his favorite spots and Bob searching downriver. The depth finder showed nothing


on the bottom most everywhere we looked. After what seemed like an hour, we still had not marked anything that looked like fish. We settled on anchoring above what looked like bottom structure and set out four baits in the current. It didn't take long. Bob was rigging another rod when we had our first bite.

This is where the what-ifs take over. We both watched as Bob's backup rod began to bow, and then the four-pound test line started moving out of the reel. That's when Bob, from the goodness of his heart, said go ahead and get it! I took the rod from the rod-holder and the fight began. The fish took off with the current and kept motoring until about half the line was off the spool. It was such a slow, steady pull that it seemed he wouldn't stop. Just when I was ready to say we should chase him, the fish stopped and turned into the current. It came about half way back and then turned away again. This went on for about 45 minutes, with the fish surfacing once about 40 yards from the boat. It was time to change tactics.

We decided to release the anchor and fight the fish from above. It didn't take long to get over the cat, but it still wanted to be near the bottom. I was beginning to make some progress when Fred and Jim showed up to watch. Bob had his hands full keeping over the fish using the trolling motor, so we asked Fred to come aboard and net the fish. As Fred and I watched, we got our first look at a real bruiser when it swirled off the starboard side. It was big!! Eventually the cat gave Fred a shot, and he skillfully slid the net under him and gathered himself to pull it into the boat. Fred's first comment was "this is the one!!"

A quick check of his weight in the net showed 57 pounds!! We knew we had a potential record fish, so we had to get to land to weigh it. A nearby dock provided a good platform, so away we went. As Bob and I tied up the boat, Fred kept the fish in the water to keep it alive. Our mission was then to get all the measurements and pictures quickly and revive and release the fish. Out of the net, the fish scaled out at a full 55 pounds!! The length was only 45 inches, but the girth was a whopping 30-_ inches!!

It was indeed the catfish of a lifetime! This was my lucky day! And yet, all I really did was wind in the fish. I am certainly proud of the catch, but the real heroes are LeRoy, Bob and Fred! I thank you all. What a great day for the Virginia Anglers Club!

The day started out with Bob Shepherd entertaining us for two hours as he threw perfect circles with his big cast net trying to catch enough bait for the days fishing.one day he may actually catch some! As it turned out not much bait was needed since the catfish were not on a big feed but some quality fish were taken topped by one super fish. Kelly Stafford reported one fish of about 25lbs. Jim Farrell and I managed to get fish of 31, 28 and one in the upper twenties. New members Mike Baucom and Dave Harris landed a few fish and were joined by Mike's 16 year old daughter Kelly. Kelly showed them how it is done by landing a 44lber.on jungle tackle! Mike was heartbroken after losing a good fish after a two hour battle on 2#. Dennis Cline laid down his surf rod for a day to sample the blue cats and managed an unbelievable 55lber. on 4# general. At present we most likely have the best blue catfishing in the world right at our doorsteps. Our last two catfish tournaments that have each produced pending world record catches.

Approximately 5 miles past West Point exit. Exit here and head east to West Point. Approximately 5 miles past West Point you will take a right on Rt. 14. This will take you to Rt. 17 where you will take a right and be heading south toward Gloucester. Continue south on 17 to the second stoplight (Business 17). Take a left here. You will now be in the town of Gloucester and heading to Gloucester courthouse. You will go just a little way and take a left on Rt. 616. (This is before you get to the Courthouse). Follow route 616 for about one half mile where it ends at the Ranger Station at the lake. This is electric motor only. Launch fee is \$6 daily or \$60 for an annual pass. Boat, motor and battery are available for rent

Beaverdam Reservoir is 635 acres with an average depth of 14-16 feet to a maximum of 28 ft. Coves have abundant standing timber. This is a great lake for a trophy largemouth bass. Try crankbaits, jig and pigs, and plastic worms.
