September 28, 2021. 7:00PM (ZOOM Meeting)

Bill Goldsborough & Allison Colden: The History of Menhaden Management in the Chesapeake and Along the Atlantic Coast

Bill Goldsborough retired in 2018 after a long career as Senior Fisheries Scientist with the Chesapeake Bay Foundation (CBF), during which he was directly involved in management of rockfish during and after the moratorium of the late 1980s, as well as menhaden management and oyster restoration beginning in the 1990s. In the late '90s and the 2000s, he served with distinction for ten years as Maryland's Governor's Appointee (citizen) on the Atlantic States Marine Fisheries Commission (ASMFC), sitting on both the Striped Bass and Menhaden Management Boards. Bill will share a timeline of the history of menhaden from its very beginnings as a new Chesapeake fishery in the 1870s to a point about three years ago. Dr. Allison Colden, CBF's Maryland Fisheries Scientist, holds a Ph.D. in oyster research from VIMS and the proxy seat for Maryland's Legislative Appointee on ASMFC's Menhaden Management Board. She has been an active voting member of that board for the last three years and will share how things have changed over that time. They will speak from CBF's broad point of view on conservation of both species, including comments about ASMFC's role in Chesapeake fisheries management.

October 26, 2021. 7:00PM (Bass Pro Shops)

Pat Geer, Chief of Fisheries at the Virginia Marine Resources Commission

As Virginia's marine fisheries chief, Pat has a seat on ASMFC's Menhaden and Striped Bass Management Boards. He will update us on the VMRC, menhaden management, and commercial electrofishing of blue catfish. He will also answer questions about your favorite saltwater species, such as cobia, speckled trout, and rockfish. Pat will speak from the point of view of state government management of marine fisheries.

November 23, 2021. 7:00PM (Location TBD)

John Bello, Government Affairs Chair, Virginia Saltwater Sportfishing Association (VSSA)

John Bello, a retired businessman and dedicated surf angler from Ashburn, Virginia, has been involved with Chesapeake Bay fisheries management since he helped co-found the Coastal Conservation Association's Northern Virginia Chapter in the late 1990s. He was one of the founders of VSSA in 2015 as an umbrella group that serves as a voice for private citizens who are members of Virginia's historic independent fishing clubs (including ours). John has been especially active in the past several years representing Virginia's anglers in menhaden and rockfish management at VMRC and ASMFC.



Frank Hart and I spent ten days on the upper James River this past August. New VAC member Scott Anderson drove us, our gear and the Tripper (our canoe) to the headwaters of the James in Iron Gate, VA. The three of us paddled and wade fished upriver (about a mile) to the confluence of the Cowpasture River and the Jackson River. We found the upper most point where the clean waters of the Cowpasture mixed with the turbid waters of the Jackson, each of us put one hand in both tributaries, drank a beer, turned and wade fished back to the Tripper a few hundred yards downstream. After a few hours of enjoying the expedition, Scott jumped in the truck and headed back to Richmond while Frank and I began our adventure down the James.

Our plan was to fish our way to the Snowden boat ramp, 68 miles downriver. On the morning of day five, we rose up, fished the pre-sunrise hour and broke camp on the small island bordered by different waters on either side. One side had a 100-yard-long rapid with eddies mixed along both sides and was full of smallmouth bass. The other side was a long, slow deep-water hole with strong musky potential. We caught a pile of smallmouth bass, sunfish and fallfish and tried for musky but to no avail. The most interesting catch was Frank's 1-4 Northern Hogsucker. Once the canoe was loaded, we began to fish and drift downriver. A short distance away, we saw a big green sign strapped to a sycamore tree announcing the "river mile" we had traveled thus far from the headwaters. Our ten-day target was 68 miles and five days in, shining in the mid-morning sun we drifted past, "Mile 5". We chuckled and agreed that we had been fishing the way we wanted to … tirelessly, from sunup to sundown … and if 68 miles was not in the cards, we'd just take out wherever we happened to be on day ten.

Over those first five days Frank figured out the smallmouth bass pretty well, and most of the 12-14" fish, were tight on structure, and a senko worm, rigged weightless did the trick. The senko worms we used were made by new VAC member Cliff Phipps and commented often how much better his baits fished than other store-bought soft plastics. We landed one musky on day three that hit a glide bait, and missed a few others, including a colossal musky that bit through 80-pound leader. It was disheartening to lose a fish like that, but we did see it, and it truly was an upper James Sasquatch.

The next two days we tore up smallmouth bass, sunfish and rock bass with an occasional musky follow. We fished incredible water day after day, witnessed countless wildlife sightings, listened to the wild day and night and fully enjoyed each other's passion for fishing. At one point, we were in one of the best-looking locations to fish. The river twinkled with oxygen bubbles from a couple of shaded streams dumping in cooler water, and strong currents running through hole after hole with ridges, deep water and currents breaks. It was outstanding, except for the fact that it was a Saturday morning about 11am, and a local livery had loaded 150 people in canoes, kayaks, and tubes. Ack! We were in an 18' canoe packed to the gills with 600 pounds of food, beer, ice, camping and fishing gear, trying to weave our way through like a cheap video game. We made a decision to paddle past every last river floater and make way far enough that we could slow down and fish at the pace we had been enjoying in the peace and quiet we had grown accustomed to.

Much later in the day we paddled though a couple of class I and class II rapids and found ourselves in an area that looked like a place you never want to leave. We both landed a musky and missed a couple more. The smallmouth fishing was

good and we thought, "Wow! Let's camp here!" We ended up camping there for two days, and that first night at "Musky Town" (as we called this spot) the rains that had been missing us every afternoon and evening finally caught up with us. Not in the form of actual precipitation, but in the form of river rise and muddy water. The rain that had fallen in the upper watershed caused the river to rise over a foot and become muddy ... too turbid to fish anything but topwater and the smallmouth did not want to hit on the surface. "Musky Town" did not disappoint, even in the muddy water, as we both managed a musky each in the cloudy water. The muddied water was pretty much the end of our catching until the last day as we ended up paddling more and more each day, searching for another "Musky Town".

On day ten, our extraction day, the river cleared enough to begin catching smallmouth bass. We found a couple streams where clear water flowed into the river and were able to catch a few fish around those confluences. We wade fished the creeks and caught suckers, fallfish, and a few small bass. About 7:30pm that evening, new VAC member (my wife) Lynda Richardson picked us up at the Arcadia boat ramp, about 48 miles downriver from our starting point. We reflected on the trip and shared stories on the ride back, and before we knew it we were back, safe at home in Richmond. It was a trip of a lifetime. I cannot wait for the next one.


I would like to welcome Captain Chris Dollar, David Howard, and Scott Anderson as the newest members of the Virginia Anglers Club.







DO YOU KNOW THE DIFFERENCE?

<u>Virginia Anglers Club</u>



 Anglers are reminded that the introduction of novel predators can have unforeseen impacts on native or established ecosystems.

 The introduction of Alabama bass is illegal in Virginia. Alabama bass have been scientifically shown to out-compete established populations of largemouth bass and hybridize with smallmouth bass.

Invasive species cause negative ecological and/or economic harm.

Anglers who suspect they have captured an Alabama bass should take a picture of the fish, clip
off a thumbnail-sized portion of one of the pelvic fins, and store the fin clip dry in an envelope.
The pelvic fins are located on the bottom of the fish, just under the head. They should then either
contact the Department of Wildlife Resources at: fisheries@dwr.virginia.gov or 804-367-1293.
